Now that it is finally over, we need a big dose of civility. Can we now stop screaming at each other, and have a reasoned discussion about how to address Ohio's real, pressing problems?

Let's talk about how we are going to provide:

- \* transparent, responsive government
- \* affordable public safety
- \* good education for all, for jobs and citizenship
- \* safe housing
- \* adequate food
- \* clean water and air

- \* affordable physical and mental health care
- \* safe transportation system
- \* jobs to pay for all these needs

### At the Polls by Ann Henkener

I was one of many Ohio citizens who worked the polls this general election. Half of the 10 poll workers at my location in Upper Arlington had worked there before, and we are pretty adept at getting the polls open and the voting machines up and operating. Voters are familiar with the DRE voting machines and didn't have many problems. We had only one voter who left the room without completing his ballot. We ran after him and he came back and finished voting. The notable part of the day was the frustration of voters who didn't have proper identification under Ohio's requirements. One man really wanted to cast a regular ballot and had even checked with the Franklin County Board of Elections to be sure he could do that even though he had moved within his precinct but had not changed his address with the Board of Elections. He had copies of the materials saying he could still vote a regular ballot. However, a notice mailed from the Board had been returned to them unclaimed (because he had moved) so he was required to vote a provisional ballot and was pretty upset.

In another instance, a woman came in who was properly in the poll book at her current address. However, she had an out-of-state driver's license, which is not acceptable ID. We reviewed with her other forms of ID and she came up with the registration for her car, which was in her husband's name. Again - unacceptable ID. Fortunately, she was persistent, and came back a third time. I don't know what she showed as ID, but she did have an Authority to Vote slip, so the third time was a charm for her. Another voter was a first-time voter and an OSU student. She was still voting at her permanent address with her parents in Upper Arlington even though she lived on campus. She had her OSU student ID card, but it didn't have an address on it, so it wasn't acceptable ID. She needed to go back to her dorm room and get her driver's license. Fortunately her mother was with her and drove her back to OSU to get her driver's license and I saw her voting later in the day. Not a great experience for a first-time voter.

Certainly a balance needs to be struck between encouraging voters to vote and making sure they are who they claim to be. I think we need to strike the balance more toward the side of encouraging voters to vote. These voters persisted and eventually voted. However, I know there are voters who won't persist after being turned away or don't have time to come back to the polls one more time that day. Democracy is the loser when voting becomes too difficult.

## From the Board

The 2010 election is finally over. Regardless of whether your candidates won or lost, I suspect you are as grateful as I am that the constant barrage of negative political campaign ads is over as well.

Across the country, voters were overwhelmed by millions of dollars of negative ads, but we don't even know who paid for many of those ads. Two weeks before the election, I was in Boston and New Orleans. Amazingly, I saw some of the same negative campaign ads for candidates in those cities. Only the picture, name and race were changed, the rest of the ad, including the music and scripted voice-over, was exactly the same as those we were seeing in Columbus!

In January, 2010, the Supreme Court of the United States handed down its decision in *Citizen United vs. Federal Elections Commission*, fully legalizing corporate and union donations. Now that the midterm election is over, we can get a clearer picture of the effect of that decision on our election process and what it portends for future elections if something isn't done to restore transparency.

The Supreme Court ruling allowed this election to be the most costly and least transparent midterm election in recent history. Outside groups were able to raise and spend a reported \$126 million on elections without having to disclose the source of these funds giving corporations, unions and others the ability to buy enough airtime to make meaningful

discussion about candidates and policies impossible. According to Public Citizen, a non-profit, non-partisan lobbying organization, in 58 of 74 national election contests that changed hands, winning candidates rode the wave of cash from shadowy groups, giant corporations and the super rich.

As League of Women Voters US President Elisabeth MacNamara said after the election, "The incivility and tone of the 2010 campaign reached a disturbingly new low in American politics." This was true not only in the advertising, but also in candidate forums and in the public discourse.

Prior to the election, Congress attempted to pass the DISCLOSE Act, which would restore transparency to US elections by requiring disclosure of corporate and union spending in candidate elections, and requiring outside groups to disclose the source of their money. It would also force disclosure of the financial backers of a political advertisement within the message, prohibit political spending by companies with 20 percent or more foreign ownership, and restrict ads by some government contractors.

It is time for action. The League calls on Congress to pass the DISCLOSE Act. Congress should also preserve and extend ethics enforcement. We have witnessed all the special-interest money spent in this election; now is not the time to cut back on the enforcement of ethics standards in Washington.

"We have to serve the truth as candidates for public office and not mislead, misguide, misdirect the people merely to provoke emotional responses and win votes that way".

## Advocacy Committee Report

Election season was quiet for the Advocacy Committee because we chose not to take a position on any local ballot issues – even as we provided helpful pro and con arguments for the library levy and city charter amendment in the Voter Information Bulletin. *The Other Paper* gave us 15 minutes of fame: A chance to restate our displeasure with the poor wording of the city charter issue – a question of maintaining the current practice of open meetings in all circumstances versus permitting executive session in certain circumstances – with an article in the Oct. 21 edition. (See our Facebook page for a link to the article.)

The committee took the lead at October units, facilitating two fascinating discussions of state tax and finance as part of the state League's update of its position. If concern that your eyes would glaze over with boredom from a debate about state government revenue sources kept you from attending, then you missed out on an educational and lively exploration of such issues as equity and fairness, means testing, personal versus corporate responsibility for taxes, and more. All just in time for the BIG debate in the legislature next year over the state budget and the projected \$8 billion deficit. (Many thanks to Nancy Brown for facilitating the Morning Unit.) How did the consensus of Metro Columbus members stack up against those from other Leagues around the state? Stay tuned!

The Advocacy Committee is looking forward to a busy New Year. A new General Assembly and a new Congress will be inaugurated in January, and LWV-Ohio will be counting on us to interview new and returning legislators. This is our opportunity to build relationships with policy makers at the state and federal level. (See related article about election results.) Metro League members will also have the opportunity to weigh in on state program planning – the biennial process by which we revisit all of the state League positions to decide which should be retained and modified – in the run-up to this spring's State Convention, May 13-15 at Maumee Bay State Park. We will also have the chance to recommend new studies, updates to existing positions, or concurrence (a process by which the state League adopts the position of another League without going through a study). There is already some energy building around a move to ask the state League to concur with Metro League's new position on public transit. Stay tuned for news of a program planning meeting in January or early February.

Speaking of studies, if you are interested in serving on the national study committee examining privatization of government services, submit your resume and application to LWVUS by Dec. 16.

There is a lot of local League activity – even with the election behind us. If you have ideas for local advocacy, join the Advocacy Committee!

## Election Results

The League of Women Voters of Metropolitan Columbus congratulates all the winners in November's general election and gratefully recognizes the service of all outgoing office holders.

Of the three state senators and nine state representatives who represent the metro area, four are new, while one moves from the House to the Senate. In Congress, one new face joins two returning members. Here is the lineup:

### Ohio House of Representatives

- Republican Anne Gonzales replaces Democrat Marian Harris in the 19<sup>th</sup> District;
- Democrat Nancy Garland retains her seat in the 20<sup>th</sup> District;
- Republican Mike Duffey replaces Kevin Bacon (who won election to the Senate) in the 21<sup>st</sup> District;
- Democrat John Patrick Carney retains his seat in the 22<sup>nd</sup> District;
- Republican Cheryl Grossman retains her seat in the 23<sup>rd</sup> District and has been appointed to serve in the House leadership as assistant majority whip;
- Democrat Ted Celeste retains his seat in the 24<sup>th</sup> District;
- Democrat Michael Stinziano replaces term-limited Dan Stewart in the 25<sup>th</sup> District;
- Democrat Tracy Heard retains her seat in the 26<sup>th</sup> District; and
- Democrat Carleton Weddington retains his seat in the 27<sup>th</sup> District.

### Ohio Senate

- Republican Kevin Bacon replaces term-limited David Goodman in the 3<sup>rd</sup> District; and
- Democrat Charleta Tavares replaces term-limited Ray Miller in the 15<sup>th</sup> District.

(The 16<sup>th</sup> District seat, held by Republican Jim Hughes, was not up for election this year.)

### U.S. House of Representatives

- Republican Pat Tiberi retains his seat in the 12<sup>th</sup> District;
- Republican Steve Stivers replaces Democrat Mary Jo Kilroy in the 15<sup>th</sup> District; and
- Republican Steve Austria retains his seat in the 7<sup>th</sup> District.

### County Offices

- Democrat Marilyn Brown retains her seat on the Franklin County Commission; and
- Republican Clarence Mingo retains his office as Franklin County Auditor.

### Issues

- The Columbus Metropolitan Library tax levy passed; and
- The City of Columbus charter amendment passed (meaning that council will be able to go into executive session to discuss certain matters, in case you, like the League, found the wording of this issue confusing!).
