## Esther Connors Named LWVMC Member of the Year

**Esther Connors'** first taste of volunteerism began in 1969 when she moved to Westerville and started shepherding her four daughters through the Girl Scouts. After a year, she said, "I needed to do something for me!" She explored what the League of Women Voters offered as an organization and decided the League definitely met her needs. For the total sum of \$5.00 she joined the Westerville League. She first volunteered to be on the nominating committee. Later, she said no to the office of president because she felt she could contribute more by getting good people to serve on the Board. Esther has continued that legacy with the Columbus League.

However, nominating committees weren't enough. Esther became a LWVO lobbyist for Juvenile Justice for several years where she conducted a study of the juvenile court system. She was also a special advocate for abused and neglected children. While a member of the Westerville League, she joined with the Columbus League on water issues and volunteered to go to many Unit meetings to talk about environmental issues—water, air, energy and strip mining. She was not a stranger when Westerville and LWVMC merged in 1998.

Esther also volunteered to go to Africa as part of the State Department and LWVUS joint efforts to introduce the concept of volunteerism and grassroots democracy to Ethiopian women. In return, several Ethiopian women came here and stayed with Esther during some of their time in Columbus. The Ethiopian women were introduced to our government-provided services such as the Health Department, Children's Hospital and Agriculture Department.

Esther's diligence was especially appreciated this year. When LWVMC needed someone to contact (and re-contact) sponsors for Democracy in Action, Esther came to the rescue. She got their responses. Without her, Democracy in Action would not have been the success it was.

## FROM THE PRESIDENT...

It has become customary to use this summer column to reflect on the highlights and challenges of the past League year. 2006-2007 was a busy, active year filled with both our cherished traditional efforts and some unique new activities.

**Our voter service activities continue to be the “centerpiece” of LWVMC.** In partnership with the Franklin County Consortium on Good Government, nine candidates forums were held throughout Franklin County. The *Columbus Dispatch* printed and distributed over 400,000 copies of the *Voter Information Bulletin*. League members registered voters and staffed the WBNS-10 TV phone bank on Election Day. The Central Ohio Civic Directory, a “must-have” resource for contacting local officials, was published and made available to the community.


**Increased local advocacy** continued to take root as LWVMC took a position in favor of the COTA levy and researched economic segregation in Ohio’s public schools. Discussions at the May units focused on the need for local advocacy.

Our educational focus saw a new dimension as we sponsored two very successful public forums: the ImPACT Forum on political accountability, redistricting and judicial reform, and the Voices of Poverty, a project in support of the United Nations Millennium Campaign. Both forums brought increased visibility and new members and friends to LWVMC. We also hosted LWVUS President Mary Wilson and LWVO Co-President Carol Gibson at our September general meeting, discussed issues of homeland security with Retired Major General Todd

Stewart at our November meeting, and participated in state program


planning in January. Units met and discussed issues of voter protection, downtown development and local advocacy.

LWVMC also financially supported and participated in the first Columbus Parent Conference.



**As always, the Board seeks ways to strengthen our organization.** This past year we began implementing the recommendations of our Marketing consultant. I hope you are pleased and proud of our “new look” and new membership and promotional materials! We participated as a control League in the LWVUS Membership Recruitment Initiative. The combination of dynamic programming, new materials, and the incorporation of membership recruitment in every League event resulted in 59 new members! We also formed a Technology Committee to focus on developing our web site and exploring innovative ways to use technology. Successful fundraising efforts included the Holiday Party, the end-of-the-year friends’ letter, Democracy in Action, the LWVO Phonathon and Meals on Wheels delivery. The Board also opted not to renew its membership in Community Shares of Mid-Ohio (COSMO).

While this year was packed with activity, accomplishment and growth, it was not without its challenges. While we recruited many new members, we continue to be concerned about members that choose not to continue their membership in LWVMC. We want to grow in diversity. And we hope more of our members will become actively engaged in planning and participating in the opportunities League offers. Attendance at units and general meetings is a concern as is the continuing challenge of visibility and fundraising. As we plan for the upcoming year, the Board will build on the successes of the year past and develop strategies to address our challenges. Goals for the upcoming year will be finalized at the August 6 Board meeting and shared through this column in September. As always, I and other members of the Board welcome your comments and input as we chart the direction of LWVMC for 2007-2008 and beyond.



## League Makes an imPACT

On Saturday, May 5, 2007, at the Sheraton Suites in Cuyahoga Falls, during the bi-annual Convention of the League of Women Voters of Ohio, a statewide imPACT Town Hall Meeting was held. imPACT recognizes and honors individuals and organizations that have made an impact on civic life by promoting citizen involvement and education. The Ohio League believes the kind of civic engagement and citizen participation promoted by these honorees provide the key to make democracy work throughout our state, indeed throughout the nation.

Honorees for this Town Hall Meeting included: Akron Community Foundation, Akron International Friendship, and the Ray C. Bliss Institute of Applied Politics. Each has demonstrated a unique commitment to promoting citizen involvement and education as a means of enhancing our democratic community.

Participants learned about two burning issues: the role of big money in shaping public policy, and its threat to judicial impartiality and fairness. Catherine Turcer, with Ohio Citizen Action and Bill Rich, a professor at University of Akron School of Law, experts in campaign finance regulations and judicial elections respectively, spoke about these issues.

Presentations set the stage for rousing round-table discussions. No one left the Town Hall meeting without having learned something new about these critical issues and everyone talked about a range of solutions that would help mitigate the problems that jeopardize the quality of our democracy. Without grassroots support for change, change is unlikely to happen.

## Public Rally Slated for September 26

*From time to time, LWVMC prints materials and publicizes events of other organizations (events in which the League is not involved) if we think they may be of interest to our membership. We feel the information below meets that requirement since LWVO has a position against the death penalty.*

On September 26, 2007, the American Civil Liberties Union (ACLU) of Ohio along with coalition partners Ohioans to Stop Executions (OTSE), faith leaders, and other community groups, is sponsoring a public rally calling for the end to executions in downtown Columbus. Events, complete with celebrity guests, will include a march, rally, prayer vigil, teach-in, and lobby day.

The ACLU opposes capital punishment in all circumstances and for many reasons. It is a violation of the constitutional ban on cruel and unusual punishment, it is administered arbitrarily and unfairly, fails to deter crime or improve public safety, and there is overwhelming evidence that exists suggesting the application of capital punishment is discriminatory. Did you know that the best predictors of whether someone will be sentenced to death are based more so on race, socio-economic status and the geographic location where the crime was committed rather than the crime itself?


Furthermore, Ohio recently had its second botched execution since the state resumed executions in 1999. On Thursday, May 24, 2007, at the Southern Ohio Correction Facility in Lucasville, Christopher Newton was scheduled to be executed at 10:00 am by lethal injection but was delayed for two hours because executioners were unable to locate veins in Newton's arms. Newton, 37 years old and weighing at least 265 pounds, was stuck at least 10 times by the prison medical staff with needles to get in place the shunts where the needles were to be injected—and yet the state continued to try. He was even allowed a bathroom break.

The fact that he had to sit and endure such mental, emotional, and physical exhaustion is beyond cruel and unusual punishment and intolerable. A change must come in this state. Help put an end to the death penalty in Ohio. Stand up for justice on September 26 in Columbus.

School, religious groups, and community organizations are welcome to participate. Large groups are encouraged to send buses or arrange carpools. In addition, co-sponsoring and tabling opportunities will be available. Please save the date!
